- ✓ **PENNDOT changes age requirement for photo ID cards.** PennDot will make photo identification (ID) cards available to Pennsylvania residents ages 10 and older. The previous minimum age requirement to obtain a photo ID cards was 16. To obtain application for photo ID card (Form DL-54A), go to [www.dmv.state.pa.us](http://www.dmv.state.pa.us) under Driver License/Photo ID Information Center. The completed form, along with the required identity documents and a fee of \$12.00 must be presented at the PennDot Driver License Center in order to obtain the photo ID.
