

# Central Valley School District

## Board Briefs

At the Combined Work and Voting Session of the Central Valley School District held on July 9, 2009, action was taken on the following:

- To appoint Verna Sisk as Board Treasurer for a term of one year (July 1, 2009 through June 30, 2010) with a yearly stipend of \$250.00. Mrs. Sisk requested her stipend be donated to Project Graduation at Center and Monaca High Schools
- To enter an agreement with Headstart to provide breakfasts and lunches for their Monaca and Rochester programs. The meals will be provided through Nutrition, Inc. and prepared at the Monaca Jr/Sr High School Cafeteria
- To approve Dr. Jason Rodriguez conducting the student physical exams at Center High School, Center Middle School, Todd Lane Elementary and Center Grange Primary School for the 2009-2010 school year at the rate of \$8.00 per student exam, athletic physical exams (\$10.00/exam – paid by student athletes) and to serve as team doctor for Center High School home varsity football games
- To approve Dr. Tom Stancik conducting the student physical exams and athletic physical exams at Monaca Jr/Sr High School for the 2009-2010 school year at the rate of \$15.00 per exam and to serve as team doctor for Monaca High School home varsity football games at the rate of \$100.00 per game
- To approve Dr. Michael Dragonjac conducting the student dental exams for the 2009-2010 school year at the rate of \$4.00 per student exam
- To approve participation in the Blood Lipid Screening Program for all Center Middle School seventh grade students and District employees who wish to participate. (Monaca approved the screening for Monaca Junior High students on June 18, 2009.) The cost for students will be \$5.00 and for adults \$15.00. No child will be turned away if the fee cannot be paid. Parental or guardian permission must be granted before any student participates in the screening. The tentative date for the screening is October 21, 2009
- To adopt the agreement with AOT, Inc. to provide occupational therapy services for the 2009-2010 school year at a cost of \$60.25 per OTR/L hour and \$50.00 per COTA/L hour
- To adopt the contract with Goodwin & Gruber Agency to provide student athletic insurance for Center High School/Middle School for the 2009-2010 school year at a cost of \$8,494.00. Voluntary student insurance will be available at the following rates:  
School time - \$27      24 hour - \$103    Dental - \$20    Life - \$30
- To adopt the contract with AG Administrators to provide student athletic insurance for Monaca High School/Junior High School for the 2009-2010 school year at a cost of \$3,900.00
- Ratification of existing contracts entered into by Center Area and Monaca School Districts
